

Team Sportsplex Winter League

Rules & Regulations

Division: PreK/K Boys & Girls

The **Winter League PreK/K Division** is designed to introduce young players to the fundamentals of basketball in a fun, instructional, and supportive environment. Games will be officiated with a focus on both **teaching and development**, while promoting fair play and teamwork.

General Guidelines

- Referees will both officiate and instruct players during games.
- Coaches must remain seated on the bench and are not permitted to walk the sidelines or enter the court during live play.

Ball Size & Goal Height

• Ball Size: Size 4

• Goal Height: 8 feet

Game Format

• Players on Court: Games are played 3-on-3.

• Quarter Length: Four 8-minute quarters

• Clock Operation:

- Running clock for the first 7 minutes of each quarter (stopping only for timeouts or injuries).
- o Final 1 minute of each quarter will follow standard high school timing rules, with the clock stopping at every whistle.
- The clock will also stop for all free throws.

Free Throw Line

• **PreK/K:** 8ft basket | 8ft free throw line

Playing Time

- Playing time is determined by the Head Coach.
- Coaches are strongly encouraged to provide **equal opportunities** for all players.

Admission

• Spectators (ages 6+): \$7 per person

Possession Rule

- Opening possession is awarded to the home team.
- At the start of the game, referees will line up opposing players to demonstrate defensive matchups.
- After the opening tip, possession will alternate using the **possession arrow**.
- The possession arrow will also determine inbounding at the start of each quarter after the first.

Timeouts

- Two (2) timeouts per half (60 seconds each)
- One (1) timeout per overtime period
- Breaks: 1 minute between quarters | 5 minutes at halftime

Overtime

- One (1) minute overtime period (clock stops as in regulation).
- If still tied after overtime:
 - o Game will be decided by sudden death free throws.
 - o Each player must attempt a shot before any player may shoot twice.

Backcourt Rule

- Over-and-back is not enforced in this division.
- Modified rule: If a team crosses midcourt and then returns to the backcourt, the defense may pursue.
- No 10-second backcourt count applies.

Defensive Rules

- Man-to-Man Defense Required.
- Double-teaming is not permitted. Referees will stop play and reset defensive assignments if necessary.

Violations

- **Travelling & Double Dribble:** Not strictly enforced. Referees will allow flexibility unless violations are excessive and create an unfair advantage.
- Coaches should emphasize proper fundamentals in practice, including:
 - Dribbling
 - o Jump stopping
 - o Pivot foot usage
 - Passing and shooting
